MINUTES

Pledge of Allegiance / Invocation:

Mayor Teresa Adkins led the Pledge of Allegiance. Jim Collie, retired campus minister at the University of Virginia's College at Wise, provided the invocation.

Consent Calendar:

Councilman Jeff Dotson made a motion to approve the consent calendar, which included the minutes of the March 23, 2021 regular Council Meeting, the April 12, 2021 Special-Called Meeting, the February-March 2021 Treasurer's Financial Reports, the March 2021 Police, Water Plant, and Fire Department Reports, and the April 2021 Planning Department Report. Councilman Ben Conway seconded the motion that passed 4-0.

Public Expression:

Dr. Sue Cantrell and Reisa Sloce, of the Wise County Health Department, presented COVID-19 statistics for the area, including vaccinations, case, and death numbers.

Hometown Hero Award:

Wise Town Council honored recently retired regional public health director Dr. Sue Cantrell by presenting her with the town's annual Hometown Hero Award.

Update on Chillin' and Grillin Event:

Greg Cross, coordinator of the annual Chillin' and Grillin' Event, provided a status update on the 2021 event including COVID-19 regulations, the beer garden, and breakfast provided by Council.

Discussion of Opening Town Facilities:

Town Manager Beverly Owens advised that as of the current date the Wise Municipal Building was ready to reopen to the public. She noted that there would be stipulations involved with the opening of the pool, unless state regulations change prior to the opening date. Councilman Dotson suggested that the Recreation Committee meet prior to the opening date to decide how to address regulations that may be in place near the date. Dotson further suggested that the committee be authorized to make the final decision without further Council action, due to time constraints.

Discussion of the Revised FY 2021-2022 Budget:

Beverly Owens presented amended pages to the fiscal year 2021-22 budget. In addition, Councilman Smith suggested charging travel ball teams a fee of \$100 per year for use of fields at Dotson Park, excluding tournaments. He added that travel ball teams would still be required to pay entry fees for tournament play. Smith stated that the annual use fee would help to cover costs for maintenance. Following the brief discussion, Town Manager Owens requested Council's approval of the budget with the amended field use fee. Mayor Adkins made a motion approving the fiscal year 2021-22 budget was in its final form with the addition of field use fees. Caynor Smith, Jr. seconded the motion. The motion passed on a vote of 4-0.

Closed Session:

On a motion made by Jeff Dotson and seconded by Caynor Smith, Jr., the Wise Town Council moved to convene into closed meeting for the purpose of and including:

<u>Personnel</u>—Discussion, consideration, or interviews of prospective candidates for employment; assignment, appointment, promotion, performance, demotion, salaries, disciplining, or resignation of specific public officers, appointees, or employees of any public body as permitted by Virginia Code §2.2-3711(A) (1).

Jeff Dotson asked how the change in the time of year town elections would be held (November instead of May) would affect those currently up for re-election. Town Attorney Leonard Rogers stated that to the best of his knowledge, once the change takes place, those in office would hold their current office until the newly elected officials took office in January.

Caynor Smith, Jr. stated that Ryan Adkins had volunteered to mow the fields at Dotson Park until the end of the season in May and questioned who would be mowing after this date. The Town Manager informed that Doug Bates had indicated that he would prefer to mow himself once the volunteer service ends. Owens added that a mower and trimmer would need to be purchased and stored at Dotson Park. Following the discussion, Caynor Smith, Jr. made a motion authorizing the Town Manager to transfer funds from the contingency line item for the purchase of a mower and trimmer. Ben Conway seconded the motion. The vote was recorded by roll call:
