PLEDGE OF ALLEGIANCE / INVOCATION:

Councilman Dotson led the Pledge of Allegiance. Adrian Dale, Town of Wise Street Superintendent, provided the invocation.

AGENDA CHANGES:

Town Manager Laura Roberts noted an incorrect Virginia Code Section referenced in resolutions numbered 24-29 in regard to the "keeping of inoperable vehicles". She noted that the correction was reflected in the original resolutions that would be acted upon later in the meeting.
