MINUTES

PLEDGE OF ALLEGIANCE / INVOCATION:

Councilman Smith led the Pledge of Allegiance. Adrian Dale, Town of Wise Street Superintendent, provided the invocation.

AGENDA CHANGES:

Town Manager Laura Roberts advised that due to a clerical error, the Closed Meeting Resolution on the night's agenda had been numbered incorrectly and was changed to Closed Meeting Resolution #13, 2023. Jeffery Dotson made a motion to accept the agenda change. Caynor Smith, Jr. seconded the motion that carried 5-0.

CONSENT CALENDAR:

Caynor Smith, Jr. made a motion to approve the consent calendar, which included the minutes of the May 23, 2023 regular Council meeting, the May 31, 2023 special-called Council meeting, the June 1, 2023 continued special-called Council meeting, and the June 14, 2023 special-called Council meeting, the May 2023 Police, Water Plant, and Fire Department Reports, and the June 2023 Recreation Specialist, Planning Department, and Special Events Reports. Councilman Robin Dotson seconded the motion that passed 5-0.

PUBLIC EXPRESSION:

There being no one from the public audience wishing to comment, Mayor Adkins closed public expression.

DISCUSSION OF DEPARTMENT HEAD REQUESTS:

Town Planner Reagan Walsh informed the deadline for commitment to the National Fitness Campaign project to install a Fitness Court at the Town of Wise Sports Complex was approaching. She stated Council's authorization was needed to either proceed or withdraw from the program with no penalty by July 7, 2023. Walsh added the Town had secured grant funding for the project in the amount of \$30,000 from the National Fitness Campaign and \$50,000 from the Rapha Foundation, leaving a total of \$165,000 left to raise or for the Town to absorb from the FY23-24 budget. Councilman Smith expressed his support to continue both the project and fundraising efforts. Vice-Mayor Conway and Councilman Jeffery Dotson also voiced support for the National Fitness Campaign project. Town Attorney Leonard Rogers advised Mayor Adkins that a motion was not needed to authorize the continuation of the project.

Special Events Coordinator Natasha Proulex informed that Boy Scout Gabe Ringley, of Troop #630 - Wise, requested Council's permission to install a sign language board in Arrowhead Park as part of his Eagle Scout project. She added that Street Superintendent Adrian Dale would be consulted regarding the proper placement of the sign. Council concurred with Ringley's request.

Natasha Proulex, Special Events Coordinator, informed the Town of Wise would be hosting the Virginia State Cal Ripken baseball tournament at the Town of Wise Sports Complex July 6, 2023-July 10, 2023. She requested permission to include day passes to the Town of Wise Municipal Pool in bags containing Town of Wise promotional merchandise to be distributed to all baseball players during registration. Council concurred with Proulex's request.

Special Events Coordinator Natasha Proulex requested permission to close a portion of Main Street for a car show to be held during the concert scheduled for September 16, 2023 at Big Glades. Council approved the closure of Main Street for the event.

Town Manager Laura Roberts expressed gratitude to the Town's Water Treatment Plant staff. PUBLIC SAFETY COMMITTEE REPORT:

Jeffery Dotson, Chair, summarized the meeting of the Public Safety Committee held to discuss a resident request to place No Parking signs along the public portion of Safenest Drive. Dotson stated a resident of Fernwood Lane expressed safety concerns due to vehicles being parked along both sides of Safenest Drive, making it difficult to see oncoming traffic on Main Street. He added that committee members visited the site and determined the parking to be related to a business located along the side of the road. Dotson informed the Public Safety Committee recommended No Parking signs be installed along the side of the public portion of Safenest Drive on which the business is located. There being no additional comments or questions, Vice-Mayor Ben Conway made a motion to accept the Public Safety Committee's report as presented. PUBLIC WORKS COMMITTEE REPORT:

Caynor Smith, Jr., Chair, summarized the meeting of the Public Works Committee held to discuss a request from a business owner for a reduction in two consecutive months water and sewer billings due to excessively high meter readings. Smith informed the customer had indicated no leaks were found on the premises. He added the Town had pulled the meter and shipped it to a testing

company to verify the accuracy of the readings. The test revealed the meter was reading with 100% accuracy. Smith further informed that the customer had removed faulty equipment from the premises that used circulating water to operate, resulting in the meter readings subsequently returning to normal, indicating the equipment was the likely leak source. Smith advised that following diligent review of the account, the Committee recommended granting utility adjustments to the customer's account in accordance with the Town of Wise Water and Sewer Ordinance, Section DD, #5, for the two high readings in question. There being no further discussion, Robin Dotson made a motion to approve the Public Works Committee recommendation as presented. Mayor Adkins congratulated Kevin Yates on his appointment as Police Chief following Danny French's retirement on June 30, 2023. Councilman Smith requested to read the following statement he had prepared:

"Wise, Virginia is a small town where everyone knows each other. We have a staff that knows each other and works together to make our town a better place to live, work and play. Our staff knows our town. When you come to work for the Town of Wise, putting in your time, dedication, and loyalty, you expect to get rewarded with increases in pay and promotions. In the past, the Wise Town Council has promoted Town Managers, Town Clerks, and past Chiefs of Police from within their respective departments.

These people know our town and know what our citizens and businesses need. We don't have a lot of crime in Wise and we don't have the reputation of harassing our citizens. Police departments are known to "protect and serve". I believe our department does that and probably with an emphasis on serving.

We had three officers within the Town of Wise Police Department that applied for the Chief position. Together they have over sixty-eight years of employment, dedication, and loyalty to our town.

Having been on the Wise Town Council for over 33 years, I've always supported our employees. I believe it's in the Town's best interest to continue developing and supporting our people to take leadership roles to move our town forward. It worked for us in the past and will continue to work for our town in the future.

This is mainly my reason for voting as I did and from this point forward, I will have no additional comments on the issue."

Councilman Smith stated that he would support Council's decision and congratulated Kevin Yates on his appointment as Town of Wise Police Chief. Smith added that he looked forward to working with Yates.

Jeffery Dotson congratulated Kevin Yates and stated he looked forward to working with him. Dotson thanked all law enforcement officers in attendance, especially Danny French for his many years of service to the Town.

Mayor Adkins thanked all law enforcement officers in attendance for their service to Wise County and the Town of Wise. She expressed her gratitude to Chief French for his service to the Town.

STAFF COMMENT:

Town Manager Laura Roberts advised a joint meeting with the Town of Wise Planning Commission may be necessary at the July 25th regular Council meeting to address a Conditional Use Permit Application for the L. F. Addington Middle School gym project.

Police Chief Danny French thanked Council for their tremendous support over the years.
