# **MINUTES**

#### PLEDGE OF ALLEGIANCE / INVOCATION:

Connor Proulex of Boy Scout Troop 630 led the Pledge of Allegiance. Adrian Dale, Town of Wise Street Superintendent, provided the invocation.

#### **AGENDA CHANGES:**

Town Manager Laura Roberts advised that there were no changes to the agenda.

#### **CONSENT CALENDAR:**

Caynor Smith, Jr. made a motion to approve the consent calendar, which included the minutes of the August 22, 2023 regular Council meeting, the June 2023 Treasurer's Financial Report, the August 2023 Police, Water Plant, and Fire Department Reports, and the September 2023 Recreation Specialist, Special Events, and Planning Department Reports. Ben Conway seconded the motion that passed 5-0.

#### **PUBLIC EXPRESSION:**

There being no one from the public audience wishing to comment, Mayor Adkins closed public expression.

#### **UPDATE FROM UVA-WISE:**

Chancellor Donna Henry provided an informational update to Council regarding UVA-Wise. She informed total enrollment for the fall 2023 semester at the college was 1,906 students. She noted that 387 first-year students were enrolled, which represented a 25% increase from the previous year. Henry added 106 new transfer students were enrolled, which was a 15% increase from the prior year total. The Chancellor notified that a master's degree program in Education had been newly implemented for the fall 2023 semester as well. She continued by stating that student housing was over capacity, which was being addressed by converting office space and common areas of residence halls into individual living spaces. Henry noted as the College continued to grow, help from the community would be needed to house students and cited Walk2Campus and Cavalier Housing as examples. She advised the College would also be interested in partnering with the Town of Wise in any way possible to add student housing facilities to the area. Henry informed that The Little Cavaliers Early Learning Center, a fully licensed Virginia childcare center for infants through Pre-K, had opened to faculty, staff, and students and would be open to the community within the month. She announced the College would be adding programs in Data Analytics, as well as Tourism and Hospitality Management, and opined the new programs would help attract new students to the school. Chancellor Henry advised the College was considering

opening a bookstore in Town for citizens to buy UVA-Wise merchandise and books without having to travel to campus. She thanked the Town for sponsoring events for students and expressed a need for the College to work more closely with the Town of Wise to encourage a higher rate of participation in such events.

Town Planner Reagan Walsh provided a brief overview of a Conditional Use Permit application submitted to allow the use of a duplex unit as a short-term rental. Walsh noted the Planning Commission recommended that Town Council approve the application for the operation of a short-term rental at 331 A Masonic Avenue as a conditional use. A public hearing was held on "A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WISE, VIRGINIA APPROVING A CONDITIONAL USE PERMIT APPLICATION SUBMITTED BY TIMOTHY HUDSON FOR USE OF AN EXISTING STRUCTURE LOCATED AT 331A MASONIC AVENUE AS A SHORT-TERM RENTAL IN AN R-B MEDIUM DENSITY RESIDENCE ZONING DISTRICT". #### **RESOLUTION #53, 2023:**

Town Manager Laura Roberts advised Town staff recommended Council reject both bids received during the August 31, 2023 bid opening for the Seven Water Tank Rehabilitation Project and the Birchfield Road Pump Station Improvements Project. She stated the recommendation was based on the Town not receiving any bids on two of the four total contracts, leading to the exploration of other options such as obtaining a tank maintenance contract. She added such a contract would allow the regular maintenance of all tanks, as well as bringing unrehabilitated tanks up to standard. Roberts stated contractors in the area that do the specialized work prefer only to do so under maintenance contracts. She noted several localities within the County of Wise currently have tank maintenance contracts. In addition, Roberts advised the consultant would also aid in the development of branding and wayfinding standards for vehicles, pedestrians, and primary entrances to Town, as well as destination identification signage for cultural, parks, recreation, and civil locations. She added that The Lane Group, under the 2023 Retainer Agreement with the Town, had presented a Task Order Agreement for said professional services in the amount of \$41,691.00.
